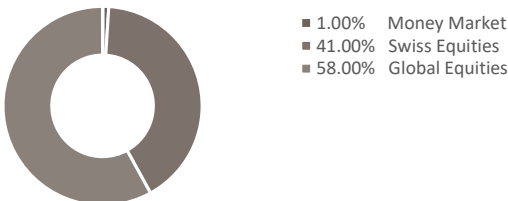
### Description

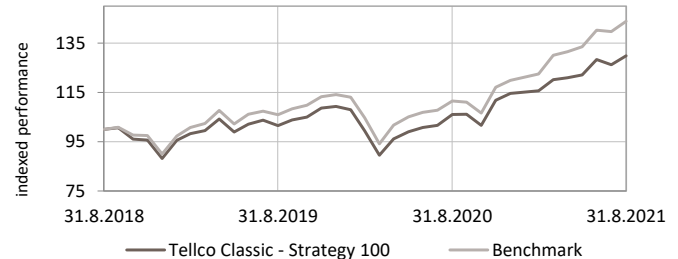
